 Inadequate working tools: Bango Kitita which was important in discussions were not readily available; that caused inconveniences to our volunteers during the discussions sessions in groups. 	 KAYD temporarily withdrew bango kititas from the old volunteers and issued them to new ones waiting for arrival of other bango Kitita, 	
Demand of incentives to new support groups members.	 KAYD continues education on the importance of six behaviors of the MTOTO MWEREVU project, and that at the end of all it is beneficial to the community and the whole nation at large. 	
 Lack of mobile phones with capacity to carry and play messages during the discussion of support groups 	 KAYD supplied hard copies with the same messages to the beneficiaries, although, they are not the same as direct listening. 	
 Few attendees and postponing meetings due to agricultural activities during rainy season 	 KAYD kept rescheduling its work plan so as to fit in their time table
